Jane Henrici is an anthropologist specializing in research and programming focused on gender and other disparities. She is lecturer at George Washington University, senior research fellow with the Institute for Women's Policy Research, and independent consultant. Her publications and presentations include analyses of economic development, poverty, labor, welfare, health and other care, and political participation as these affect diverse women and their families across different nations.

Sabine Klocke-Daffa is Senior Researcher in Social and Cultural Anthropology at the University of Tübingen/Germany. She has done intensive fieldwork in Namibia. Her research interests include cultural networks of sharing and exchange, gender, basic income, social security and formal insurances in Africa, and Practicing Anthropology.
